

A GROWTH FORMULA (LUTTNER 2012)

$$\theta_E = \theta_I + \sigma \sqrt{2\beta}$$

θ_E : growth rate of the economy

θ_I : drift of individual log productivities

σ^2 : local variance of individual log productivities

β : arrival rate of imitation opportunities
